Subject: Important Notices of Recent Fraudulent Emails Targeting Financial Transactions and Genuine Payment Policy of Sea Value Group of Companies

Dear Value Customers,

This letter is for remind and build awareness of the recent incidences regarding strange emails or letters from unknown sources with the ultimate criminal fraudulent purposes on financial transactions and eventually jeopardizing credibility on business transactions. Such fraudulences are by imitating as correspondent parties in email communications in relation to our business transactions in order to alter our payment information and instructions by describing any reason—such as, our previous bank account have been put on hold due to tax related issues—for instance, which we are working on the issues, and then request to change company name and bank account for financial transactions. These fraudulent emails are in no way affiliated with Sea Value Group of companies and should not be regarded as such.

We would like to inform and insist that we have never issued and sent this kind of email or letter to any customer, buyer or trader for the instructions to make any T/T remittance or money transfer for any other company name, address and bank account at all. Our existing four (4) genuine email domain addresses are as follows (i) @seavaluegroup.com; (ii) @seavaluemarketing.com; (iii) @unicord.net and (iv) @isavalue.com for your referral purpose.

Please be informed that the terms and conditions for payment policy for our group of companies are as follows.

- 1) We never instruct our customers, buyers or traders to make T/T remittance or money transfer to any oversea bank accounts, other than our bank accounts in Bangkok, Thailand.
